- **3. Public Comment -** Bill Knox gave thanks for the inclusion of the Grand Jury reports on the agenda.
- Guest Speakers: Raelene Nunn and Tita Bladen of the EDC Commission on Aging, will share their Outreach plans and other topics related to senior services and housing - The Commission on Aging (COA) is an advisory Committee to the El Dorado County Board of Supervisors. The Commission works with the Director of the Area Agency on Aging on community interests and issues faced by seniors in El Dorado County. This includes, but is not limited to, developing community centers in strategic areas of the county to make services accessible to all seniors. The group also promotes services that help seniors to remain in their homes and prevent elder abuse. 14 volunteer commissioners are on the COA. 40% of the residents in EDC are 55+. COA recently had their senior of the year event; 18 were nominated and the winner was David Zelinsky. Many programs are available to all seniors in EDC and income eligibility is not a factor. To view programs and services, Commission On Aging - El Dorado County (ca.gov) The housing committee is focusing on affordable and "missing middle" housing and age friendly. Also looking at "village concept" housing that has been successful in other parts of the country. The CA Senior Legislature (CSL) consists of 40 senators and 80 assemblymembers and they are a volunteer body whose primary mission is to gather ideas for legislation at the state and federal levels, craft the ideas into formal proposals, prioritize the proposals, present them to members of the Legislature or the Congress, and advocate for laws implementing the ideas. Raelene is a senator and Tita is an assembly member of the CSL. Transportation concerns for seniors were discussed, to take the transportation survey put out by the EDCTC, El Dorado County Transportation Commission (EDCTC)Transportation Investments Survey (surveymonkey.com)

Safe and Healthy Communities - Sheriff's report, CHP report, EDH Fire report and
Healthy Communities report - Fire Chief Mo Johnson talked about the new rescue unit
#85 that was donated to EDH fire, link to video Fleet Friday-Rescue 85 - YouTube. EDH
fire continues talks with Cameron Park fire about possibly teaming up. The new training
facility is booked up through 2025 with over 100 classes. Folsom Lake and American
River will be providing units for fire fighters. Brian Leduc was named firefighter of the
year. All but 79 of 1400 vacant lots have been cleared. EDH fire premiered "Kyle's
story" to raise helmet safety awareness and the effects of traumatic brain injury, Kyle's
Story (youtube.com)

Kathi Guerrero discussed the services that the community hubs can provide, Community Hub 1 | El Dorado Community Hubs , and in the month of May the EDH hub had 39 clients with 29 children. Isolation is an issue for both youth and seniors. The commissions for Youth and Families and First 5 will start their community needs assessments. Dolly Parton's imagination library provides free books every month to children until they are 5, to join FREE BOOKS - Dolly Parton Imagination Library — Marcella Foundation :: Think Big. Make a Difference.

 Thriving Economy- Restructuring of the Community and Economic Development Advisory Committee continues with BOS briefing on June 18th

- Public Infrastructure- Plans for the new County Homeless Navigation Center have shifted to a revised site location on County property adjacent to the County Jail. It would be a 'low barrier' facility meeting all of the Fed and State funding requirements. On May 21st the BOS directed staff to develop a permanent Navigation Center with stand-alone transitional housing units at 300 Fair Lane. The BOS also directed staff to develop a temporary family area at the site.
- Workforce Excellence- An internal employee survey produced some very positive feedback and several ideas for continued improvement-more details to follow
