Molinari, President of the El Dorado County Farm Bureau, all stated that as representatives of their organizations, they favored and would support a General Obligation Bond Election, to finance a government center.

Mr. McCutcheon of California Taxpayers Association stated that their organization felt that adequate financial and site studies had been made by the Board, and proper procedures followed, over a period of time; that Stone and Youngberg's report was sound, and endorsed the General Obligation Bond method of financing.

On motion of Supervisor Chappie, seconded by Supervisor Chism, and carried, the District Attorney is requested to draft the necessary documents to prepare for a General Obligation Bond Election, to be held in early June, in the amount of \$2,125,000.00, for construction of Buildings A to L, including the Courts Building and a building at Lake Tahoe.
