At the recommendation of the Airport Committee, on motion of Supervisor Chism, seconded by Supervisor Wallace, and unanimously carried, Mr. John Nelson's request for reduction in the percentage of gross revenue, which he pays for his business permit at the Placerville Airport, was denied, based on the fact that he has no capital investment and is not in the same category or rated as a fixed base operator.
