"The following is a request that you grant a variance in Section 9371 of the Subdivision Ordinance, as applied to the above subdivision.

(Cameron Park : ... Units 1, 2 and 3)

This section requires that streets constructed within a subdivision, having lots less than five (5) acres in size, be paved with 6" of aggregate base and  $2\frac{1}{2}$ " of asphalt concrete. If the lots, however, exceed the five acre limitation, the asphalt concrete is not required.

Cameron Park South is, at this time, a private subdivision with all lots in excess of five (5) acres and all roads privately owned.

Mr. Cameron, the developer of this subdivision, would at this time like to complete the construction of roads, so that they could be dedicated to the county.

In the acquisition of right-of-way for the roads, some the existing lots will be reduced to less than five (5) acres and, therefore, technically require the developer to pave with 6" aggregate base and 2½" of asphalt concrete. This requirement would in all probability preclude construction of these roads, so that they could be acquired by the county.

It is therefore requested that variance be granted and that the owner be allowed to substitute a high quality chip seal coat in lieu of asphalt concrete.

In closing, I would add that this variance, if granted, would not in any way reduce the subdividers responsibility for providing adequate drainage, good road alignment, or any other engineering feature which would ensure a good job."
