"The El Dorado County Welfare Advisory Committee, created by Ordinance 522, hereby advises the Board of Supervisors that the Committee approves the action of the Board on August 6, 1965, in deleting \$115,253.00 from the County Welfare Budget requested for the Training Aid Program.

The Committee takes this action for the following reasons:

- 1. In our opinion the Welfare Department is not equipped to go into an educational program as outlined under the Economic Opportunity Act. California is recognized as having as good if not the best educational system in the nation and we feel educating should be left in the hands of the professional educators.
- 2. The El Dorado County High Schools had scheduled for the past Spring Quarter, 26 subjects in 34 classes in the evening Adult Education, at a very nominal fee of \$2.00 plus a small laboratory fee in some classes. Anyone wanting to better their education should be encouraged by the Welfare Department to enroll in one of these classes.

additional opportunities offered at the Los Rios Junior College soon to be built in this area.

- 3. From the information we have been furnished by the Welfare Department, the Budget for 1964-65 for State Program #109 was \$17,301.00 which represents a cost of \$4325.25 for each individual completing the course--which was 30% of the total enrolled. Using this same percentage, the cost would amount to more than \$3,000.00 per individual for the year 1965-66 with questionable results.
- 4. We feel the Training Aid Program as outlined is just another department that could grow into more than ½ million dollars in a very few years, and accomplish questionable results as far as rehabilitation is concerned.
