- a. All aircraft may load and unload passengers in the three designated loading positions immediately in front of the temporary terminal building.
- b. All aircraft under 12,500 pounds gross weight will be parked in the light plane tie-down area. If such aircraft owners are to be absent from the Lake Tahoe Airport, their aircraft must be secured to the cables provided for this purpose using the chains provided by the County. Unless such procedure is followed, the County will in no way be responsible for the safety of such aircraft even though the aircraft owner has paid a fee for such parking.

- c. All aircraft over 12,500 pounds gross weight are to be parked at the extreme South end of the transient apron.
- d. After parking any aircraft over 12,500 pounds gross weight, the pilot will be responsible for completing the following operations:
 - Place chocks in front of and behind main gear wheels or wheel
 - (2) Place chocks in front of and behind the third gear wheel or sheels
 - (3) Place a drip pan under each engine
 - (4) Set the brakes and lock the controls of the aircraft.
- e. Before starting any aircraft on the transient apron, the pilot will be responsible for seeing that the following operations are completed:
 - (1) The drip pans are removed to the granite area along the edge of the apron without spilling oil the length of that apron
 - (2) That no motor vehicles are allowed to move in the transient apron area in the vicinity of the aircraft.
- f. Whenever an airline aircraft of any size is on the transient apron with its engines turned up preparing to load or unload passengers or to move its position on the transient apron, the station manager of that airline will be responsible for seeing that the following additional operations are completed:
 - (1) The entrance gates in the chain link fence system to the transient apron are closed along the length of that apron.
 - g. The fixed base operator (Bridgeford Flying Service) will be responsible for directing all aircraft on the transient apron and carrying out the requirements of these rules and regulations.
 - h. After normal working hours for the fixed base operator (dusk to 0800) the Airport Operations Man on duty will be responsible for carrying out these rules and regulations.
 - i. These rules are effective January 3, 1966.
