"I have asked the County Administrator to compute the cost impact of last weeks action, and find that the total cost would have been approximately \$20,000 and the County taxpayers' share would be approximately \$17,400. I have also reviewed the classifications that would be blanketed in under the 2½% increase, and find several that were not in the general clerical grouping.

"In view of these two developments, I have requested the County Counsel to prepare an amendment to the Personnel and Salary Ordinance for your consideration today. This ordinance is identical to the one approved last week except that the following classifications would remain without a salary increase:

- 1. Airport Manager
- 2. Airport Maintenance Man
- 3. Cemetery Maintenance Man
- 4. Engineering Technician
- 5. Public Health Nurse I & II
- 6. Library Shelver
- 7. Clinical Laboratory Technologist and X-Ray Technician

"With the deletion of these increases, the dollar impact as computed by the County Administrator totals approximately \$17,100 with a County tax-payers share of approximately \$14,900."

After discussion, on motion of Supervisor Walker, seconded by Supervisor Lawyer, and carried by the following vote: Ayes: Supervisors Walker, Worrell, Lawyer and Martin; No: Supervisor Ronzone; the following ordinance was adopted amending Ordinance No. 922:
