Following discussion Supervisors Martin and Johnson and Airport Manager offered to act as a committee to study design and plans for terminal building at Lake Tahoe airport and report findings or recommendations to the Board. County Counsel to prepare a draft of proposed contract for limited architectural and structural services for Terminal Building, Lake Tahoe Airport by Albert V. Colosi, Civil and Structural Engineer.
