Provide 50% State of California funding of the non-federal revenues required for the Tahoe Regional Planning Agency (Compact), with the remaining 50% distributed between Placer and El Dorado Counties proportionate to their respective A. V.'s within the Tahoe Basin; this funding system to apply to the generation of funds from the California side and within the existing \$150,000 maximum Agency limits now specified by statutes of California and Nevada.

2. Establish a limit of \$100,000 for the non-federal revenues of the California Tahoe Regional Planning Agency with the State of California paying 50% and the balance distributed between Placer and El Dorado Counties proportionate to their respective A. V.'s within the Tahoe Basin; this system to terminate upon the Congressional ratification of the Compact; residual funds (except as proposed in paragraph 3 below) to be transferred to the Tahoe Regional Planning Agency (Compact) with credit given to the sources of these funds against normal funding requirements of the TRPA (Compact).

3. Upon the Congressional ratification of the Compact, the maximum non-federal revenues of the California Tahoe Regional Planning Agency will be \$10,000, with the State of California paying 50% and the balance distributed between Placer and El Dorado Counties proportionate to their respective A.V.'s within the Tahoe Basin.

The above recommendations were approved and Mr. Nielsen was instructed to deliver same to Assemblyman Chappie on the 12th of March, at his office in the State Capitol, on motion of Supervisor Caswell, seconded by Supervisor Lawyer, and carried by the following vote: Ayes; Supervisors Caswell, Lawyer and Martin. Noes; Supervisor Goodloe. Abstain; Supervisor Johnson. (Supervisor Johnson abstaining by reason of his opposition to forms of regional government)
