Also that an order of the Board of Supervisors had been disregarded when the service department continued to use the Multilith and related equipment.

The Clerk explained that the Multilith was being used as a substitute for the Xerox machine which had been removed by Board order and in lieu of Mimeograph machine to perform routine duplicating for county departments.
