Inasmuch as a number of people in the audience had requested to be heard on the matter of the Sly Park Job Corps site, as well as letters and telegrams having been received, Chairman Martin suggested that those people in the audience be heard; advising them, however, that the Board could take no action at this time, but would be happy to hear their comments.

Mr. Burnett Bolloten, General Manager, Gold Ridge Forest developers, spoke on behalf of the American Forest Properties, owners of the Gold Ridge Forest properties. Mr. Bolloten stated that American Forest Properties would be spending several million dollars in the development of their properties, which in a few years could conceivably increase the population of the Sly Park area by approximately 5,000 persons, and further indicated that many of the homes would be in the \$35-40,000 class. Therefore, he earnestly requested that the Board give serious consideration to their large investment, as well as the County's potential tax revenues therefrom. Mr. Bolloten expressed grave concern that if the Job Corps site were used for a Boys Camp for delinquent juveniles it would place a stigma upon the area, thereby jeopardizing their present and future investments in the properties.

Mr. Stan Groves, under-Sheriff of the County, spoke on behalf of Sheriff Ernest Carlson, as well as himself as a property owner in the area, stating that the Camp would accommodate between 120-130 people and if El Dorado and Placer Counties could not produce the number of juveniles to fill the Camp, that possibly they would be drawn from the entire State. He also expressed concern regarding the policing of the Camp area.

Mr. Wally Behrens, Realtor in the Sly Park Hills Development, also expressed opposition to the use of the site for a juvenile Boys Camp.

Chairman Martin advised those people who were heard that if the County did not exercise their option to move on this matter, that Placer County, or the Federal Government, could make the decision on the usage of the site, and El Dorado County would then lose their control, and the County would still have to provide the necessary policing, etc. without County control.
