George Smith, Civil Defense Coordinator, was present at 10:30 A.M. and advised the Board that he had checked with Amador and Placer Counties relative to County participation in the California Community Emergency Planning Program, as directed by the Board on January 27, 1970, and learned that the only requirement of the County is that a letter of "intent and cooperation" be signed by the County requesting that the Program be conducted for the purpose of LHR Refermining overall requirements for shelters to be utilized during an emergency in this County. He further informed the Board that a contract would be involved between the Federal Government and the State of California only, authorizing the Federal Government to accomplish the Program in those counties covered in the agreement.

On motion of Supervisor Martin, seconded by Supervisor Caswell, and unanimously carried, the Chairman was authorized to sign the letter of intent and cooperation, and the Clerk directed to send copies of the letter to the Cities of Placerville and South Lake Tahoe.

Mr. T. L. Piazza, Pollock Pines, was present at 10:30 A.M. and requested that the Board lower the speed limit and place a load limit on County Road 122A (Forebay Road), which he stated was being deteriorated by heavy trucks hauling dam aggregate.
