County Administrator introduced members of the Federal and State Regional Offices of the Office of Economic Opportunity.

Mr. Frank G. Cuny, Executive Director, El Dorado County Community Action Council, Inc. was present and submitted a letter to the Board, wherein he stated that due to the merging of the poverty program into local government structure, he could not carry out that burden of responsibility inasmuch as his dedication is to independent community action programs, but that in the interest of a smooth transition, he recommended that the County and the Council adopt in principle the Transition Plan and the Board of Supervisors establish the position of Director as a department head of the County, and that he, as current Director, fill that position until April 30, 1970.

Rodger Betts, Regional Director, Western Regional Office, OEO, San Francisco, outlining certain additional requirements in order to complete the County's Application for Recognition of a Community Action Agency, and in this respect the following actions were taken by the Board:


