Hearing held as duly advertised on Appeal of Mr. Mack Dewater (Sunrise Ranch, Inc.) for Special Use Permit to allow a resident vocational training school for educationally handicapped boys, ages 12 to 17 years, on property located north and west of Traverse Creek Road, approximately 1½ miles southwest of Bear Creek Road, Traverse Creek Area.

<u>Daryl J. McKinstry</u>, Attorney for Mr. Dewater was present, and requested that the appellant make the first presentation to be followed by rebuttal, by those persons considered to be respondents, and Mr. McKinstry stated that introductory comments would be made first and witnesses would follow.

Mr. Robert L. Hopkins, Official Court Reporter of El Dorado County, was present to report on the proceedings and was requested to administer oaths to those persons appearing as witnesses.

Mr. Bruce Robinson, Executive Secretary, El Dorado County Planning Commission, was present, and stated that after a lengthy hearing on Mr. Dewater's request for a Special Use Permit, the Planning Commission came to the conclusion that due to the numerous protests from people living in the area the permit would be denied.

Mr. Mack Dewater, being duly sworn, submitted a book of photographs of buildings and areas as Exhibit 1, at the site of the proposed school. He then discussed the type of boys who would attend the school and set forth the types of training that would be available. He stated there was an adequate supply of water on the property; the school would be licensed by the State, and that special conditions would be provided on the use permit to ensure compliance with laws.

Mr. James R. Yount, assistant to Mr. Dewater, being duly sworn, submitted a petition containing 80 signatures of El Dorado County residents (Exhibit 2) in favor of the proposed ranch facility, and also submitted a map (Exhibit 3) indicating adjacent land to the proposed ranch. Submitted by Mr. Yount as Exhibit 4, indicating approval of the proposed school were letters from Mrs. Paul Churchill, Sonora; Henry Van Bebber, Hilltop Boys Ranch; Richard C. Traynham, Principal, Sonora Union High School. Mr. Yount read a letter addressed to him from Paul S. J. Wallace, Chief Probation Officer, Superior and Juvenile Court, Sonora, stating need of such schools as Mr. Dewater proposes. (continued)

Mr. Richard Milhous, Manager, Milhous Boys Ranch, being duly sworn, read a letter addressed to the El Dorado County Board of Supervisors from Robert W. Long, Supervisor of Nevada County, in which Mr. Long stated there had not been any problems with the Milhous Boys Ranch in the area of law enforcement. Mr. Milhous also read a letter from Jerome A. Gray, Realtor, and a letter signed by members of the North San Juan Ridge Riders, and submitted letters from Frank O. Bigelow, Yuba County; Dick Milhous, Assistant Administrator, Milhous Boys Ranch; J. E. Gilbert, teacher at Milhous Boys Ranch; Mrs. Charlene M. Welker, Nevada City; William L. Heavey, Chief Probation Officer, Nevada County; Wayne Brown, Sheriff-Coroner, Nevada County. Letters were submitted as Exhibit 5, and contained favorable comment about the facility at Milhouse Boys Ranch.

Mr. Bob Anderson, Director of Special Education, El Dorado County Superintendent of Schools Office, being duly sworn, stated there was need for such a school in El Dorado County for boys in this County, and a need for vocational training.

Mrs. Maybelle Timm, Kelsey resident, being duly sworn, stated she was representing people in the Bear Creek and Traverse Creek areas; that they were not in favor of the proposed school and objected to application of Mr. Dewater for a Special Use Permit as being too broad in scope, and that there were objections to the types of boys who would be attending the school. Mrs. Timm submitted as evidence, Exhibit A, Certificate of Nonfiling Corporation of Sunrise Ranch, Inc., dated September 14, 1970, from the Office of the Secretary of State, Sacramento. She further stated that there were only two Deputy Sheriffs in the area where the school is proposed and that there should be more law enforcement officers if there is to be a school of this kind, and she stated objections to the type of boys who might be placed in the school.

Mr. Stan Groves, Undersheriff, El Dorado County, being duly sworn, stated there had been some law enforcement problems with boys camps in the past and that the Sheriff's deputies were spread too thin in the area proposed for the school, and they would have to ask for more deputies if this permit were issued.

Mr. Robert Greenwood, American Flat, being duly sworn, spoke in opposition to granting the proposed Special Use Permit, stating there were extensive programs within the public education system to provide for slow learning boys, and that there is a program of compensatory education. He submitted as Exhibit B, pamphlet from State of California on compensatory education and History of Title I ESEA.

Mrs. Gracie Leonard, Kelsey, being duly sworn, spoke in opposition to the issuance of a Special Use Permit to Mr. Dewater for the proposed school.

Mr. Dewater spoke in rebuttal and submitted as evidence, Exhibit 6, being a list of nine conditions that he would agree to relative to a Special Use Permit being issued to him. (continued)
