Lewis was of a similar nature, and proper notices having been sent, the Chairman opened the hearing regarding Mr. Lewis' request to store his trailer on his 10-acre parcel located east of Georgetown Road and south of Meadowbrook Road in the Georgetown area; said trailer to be used for occasional overnight stays. No protests were presented and the hearing was closed.

On motion of Supervisor Goodloe, seconded by Supervisor Lawyer, and unanimously carried, the Board found that the use of the trailers was in accordance with the intent of the ordinance, and that for a time period limited to 120 days from January 12, 1971, the requirement for hook-ups to the travel trailers was waived.

On motion of Supervisor Goodloe, seconded by Supervisor Caswell, and unanimously carried, the Board directed that the matter of the ordinance relative to this subject be brought up again on the Agenda for January 26, 1971, for further clarification.

Hearing held as duly advertised on the request of Foothill Disposal Service for an adjustment of rates for the collection and disposal of garbage in the western franchise area of El Dorado County.

Mr. Ossie I. Scariot of Foothill Disposal Service was present and proposed a rate increase of 75¢ per month per customer for a total of \$3.25 per month; 75¢ for the second can of garbage, and 50¢ per can thereafter to cover the cost of additional equipment and manpower needed to efficiently operate his company, to be effective March 1, 1971, to afford time to notify his customers.

Mr. Bill Anderman, Director of Sanitation and Environmental Health was also present and submitted a letter requesting that Foothill Disposal Service: (1) Provide volumes and rate schedules for commercial accounts; (2) Show (Continued)

comparative cost breakdown showing overhead expenditures; and (3) Show the profit margin and adequately explain the large increase in wages, differentiating employees wages from partner's salaries; and further that the Board continue the matter until citizens within the Franchise area have the opportunity to be advised as to the exact amount of the rate increase and that the Health Department and Public Works staffs have adequately reviewed the proposal and made recommendations.

On motion of Supervisor Caswell, seconded by Supervisor Lawyer, and unanimously carried, the matter was continued to January 19, 1971, and the County Counsel was directed to coordinate with the Director of Sanitation and Environmental Health for a schedule of commercial rates to be established.

Bid opening was held on January 7, 1971, for construction of the Juvenile Hall, and bids were received from James P. Morton Construction Co., Placerville; Younger Bros. Contracting Engineers, Sacramento; Roebbelen Construction Co., Inc., Sacramento; Brown Sheet Metal & Mechanical, Inc., Oakdale; Briggs & Weston, Placerville; V. L. Gavel Construction, Inc., Carmichael; Murchison Construction Co., Sacramento; and Gil Construction Co., Pacheco. (Original bids are on file in the Board of Supervisors Office.)

The County Administrator submitted a breakdown of cost considerations based upon the low bid received from Morton Construction Co. in the amount of \$358,407.00 as follows:

\$358,407 - Construction

28,672 - Architect's Fees

\$387,079 - Total

346,500 - Amount available and budgeted

\$ 40,570 - Amount needed from Contingency

(should be rounded off to \$40,500)

The Director of Public Works recommended that the Board award the bid as outlined by the County Administrator.

The Probation Officer was present and spoke for his department and the Juvenile Justice Commission and requested that the matter be continued in order to pursue the possibility of obtaining grant funds for the construction.

On motion of Supervisor Stewart, seconded by Supervisor Lawyer, and unanimously carried, the matter was continued to January 26, 1971, at 11:00 a.m. for a report from the Juvenile Justice Commission as to the availability of grant funds.
