Hamilton submitting a request from his client, Walter Nelson, to use a portion of the Lake Tahoe Airport Lobby on the condition that he be responsible for clean-up and for any property damage, for a dinner to be held May 6, 1971, for 150 school teachers.

On motion of Supervisor Stewart, seconded by Supervisor Lawyer, and unanimously carried, the Board determined that they would take no action on this matter until the Restaurant Lease situation is settled with Mr. Nelson.
