Hearing held as duly advertised on the rezoning of lands in the El Dorado area from A, Agricultural and R1A, One Acre Residential zone, to I, Industrial and R1A, One Acre Residential zone, and an Amendment to the General Plan of El Dorado, consisting of approximately 12.90 acres, petitioned by Farnsworth Moulding, Inc. The Planning Commission recommended approval for the following reasons: The property proposed for I, Industrial has been used industrially for approximately 18 years, and the portion proposed for R1A, One Acre Residential, is the portion used by applicant for his home and would be a logical extension to existing adjacent R1A zoning. The Planning Commission recommended that the Board require a performance bond to ensure adequate screening and sound buffering by landscaping and proper fencing on the easterly property line and along State Highway 49, with the landscaping plan to be subject to Planning Department's approval.

Those present and opposed to the rezoning were Antonio D. Berardo who stated that he had submitted a Petition to the Planning Commission signed by 29 property owners in the area who were opposed to the rezoning. Mr. William Feitz was also present and opposed. There were others in the audience who were opposed but who did not care to come forward and give their names, but they did speak briefly in opposition from their chairs.

There were no further protests and the hearing was closed.

On motion of Supervisor Goodloe, seconded by Supervisor Caswell, and unanimously carried, the Board denied the petition for rezoning inasmuch as they found that the installations required by the Air Pollution Control Board to be installed by the Petitioner, Farnsworth Moulding, to meet their standards, were consistent with prior non-conforming uses, and the Board allowed the installation of the modern cross-cut saw and accessories; modernization of the waste burner; and sound proofing, which are or may be required by Government bodies.
