The letter would warn that if no response occurred in thirty-days, the matter would be forwarded to the District Attorney for further action.
- 3. If the grantor appeared and settled the matter satisfactorily, the Planning Department would return the front sheet of the document to the Assessor's office with a memo informing that office that it might proceed with the land split for tax purposes.

If, however, the grantor did not appear within thirty-days, the information would be forwarded to the District Attorney.

- 4. The District Attorney's office would then, at its discretion, send a final warning letter giving the grantor a certain period of time in which to appear (at either that office or the Planning Department) and warning that prosecution might follow. The letter would set forth the appropriate sections of the ordinance, and a simple form letter would suffice.
- 5. The minute order would also state that where a change in property lines appears to be only a boundary line adjustment in the opinion of the Assessor and the Planning Department, that change shall not constitute a land-split as contemplated by the Parcel Map Ordinance.
