#### PLANNING MATTERS

285 52 73 Hearing having been held on July 10, 1973, on the rezoning of lands in the Camino area from One Acre Residential to Agricultural zone, consisting of approximately .10 acre, petitioned by Michigan-California Lumber Company, for the purpose of extending the narrow gauge railroad across Larsen Drive to establish a fueling facility; the Planning Commission on that date having recommended denial; and the Board having failed to pass two motions to take decisive action on the matter (See Minute Book 14, Pages 311 and 312); the Board on its third motion continued the matter to this date.

A Petition was received in the Board of Supervisors Office on this date containing 69 signatures in opposition to the rezoning.

Supervisor Lane moved to refer the matter back to the Planning Commission for a rehearing on the basis of rezoning alone, without other matters involved, but failed to receive a second to his motion.

The motion of Supervisor Walker, seconded by Supervisor Stewart, to uphold the Planning Commission's recommendation of denial of the rezoning, was not carried by reason of the following vote: Ayes: Supervisors Walker and Stewart; No: Supervisor Lane; Absent: Supervisor Lawyer.

County Counsel advised that because of the failure of the Board to have a decisive motion passed, the zoning of the aforementioned .10 acre shall remain as it is presently zoned: One Acre Residential.

296-11 Mr. Milton Coffey, Chairman Highways Council for the El Dorado County Chamber of Commerce, was present and introduced Messrs. Messrs. Ray Winton and Sam Helwer, State Department of Transportation, advised the Board of a Public Hearing set by the Department of Transportation to be held at the Little Theater, South Lake Tahoe High School, at 7:30 p.m. on September 13, 1973, regarding rescinding portions of State Routes 89 and 28, freeway route adoptions along the West Shore of Lake Tahoe. (No Board action was necessary).

The Board considered claims of Shirley H. King relating to her property on 58 Echo Lake Road emanating from a dispute regarding boundary markers and actions of the Public Works Department wherein survey markers were allegedly removed and plants and plastic water lines destroyed.

After a long discussion including the County Surveyor, the Director of Public Works, and Mrs. King, the Board on motion of Supervisor Johnson, seconded by Supervisor Lane, and unanimously carried by those present, requested County Counsel to withdraw his letter of July 6, 1973 to Mrs. King advising her of his recommendations to the Board that her letter of July 3, 1973, was considered a Claim and that the Board not consider it as it was not made timely under Government Code 900, and instructed the Director of Public Works, the County Surveyor, and County Counsel to review the six demands of the County made by Mrs. King, and submit their recommendations in this regard back to the Board.
