Assessment District Attorney Hill stated that a check of the Assessor's records revealed that the Protest Notices of Edna M. MacDiamond and L. M. and Voneda Burke were not valid since they were not shown to be in the Assessment District, and that the Protest Notice of Mr. Rippy was not valid either since the lots and block numbers which he indicated he owned are shown to be in the name of Joy S. Chantry. Mr. Hill further stated that protests against said acquisitions and improvements were not signed by the owners of a majority or more of the area of the lands within the assessment district, so from that standpoint the Board could, if they desired, overrule the other protests, thereby continuing with the proceedings.

Attorney Julian C. Smith, Jr. was also present on behalf of the Johnstones; Teurmans; Stalls; and others, and stated that all of the property owners directly adjoining Jewel Road, the actual location of the improvements, were opposed to the Assessment District.

There were no further protests, and the hearing was closed.

After consideration, the Board on motion of Supervisor Stewart, seconded by Supervisor Lane, and unanimously carried, declared their intent to abandon any further proceedings on the aforementioned project.
