Results of bid openings for the El Dorado County Government Center, Phase I, located on the Hildman site, Placerville, were considered as follows: Base bid for Contract "A" -- Rough grading of site work and water supply, and Base bid for Contract "B" -- Construction of buildings, including adjacent site work.

Bids for Contract "A" were received from: Douglass-Seaburg, Meadow Vista; South Tahoe Construction, Stateline, Nevada; Ed Mallory Constructors, Citrus Heights; Reedy Construction, Sacramento; Boscarello, Inc., San Ramon; Joe Vicini, Placerv lle; Teichert Construction, Sacramento; R. C. Collet, Inc., Woodland; Syblon-Reed, Folsom; and Pioneer Construction Co., Placerville. (The original bids are on file in the Board of Supervisors Office.

Bids for Contract "B" were received from: John F. Otto, Sacramento (also submitted a combined "A" and "B" bid); Hunt Construction, Sacramento (also submitted a combined "A" and "B" bid); Nielsen Nickles, Sacramento; K. J. McGranahan, Santa Cruz; and Younger Brothers, Sacramento (also submitted a combined "A" and "B" bid). (The original bids are on file in the Board of Supervisors Office).

Architect Jack Nopp was present and recommended award to the low bidder , for each contract. Supervisor Lawyer thereupon moved approval of Budget and Fund Transfer No. 81 transferring \$100,000.00 from the Exercise Yard Parking Lot budget, and \$150,000.00 from the Contingency Fund, to the Plant Acquisition budget for the construction of the new El Dorado County Government Center, and awarded the bid for Contract "B" (construction of buildings) to John F. Otto, Sacramento, as low bidder, in the amount of \$3,630,000.00, and awarded the bid for Contract "A" to low bidder, Douglass-Seaburg, Meadow Vista, in the amount of \$144,699.00; making a total bid award of \$3,774,699.00. Supervisor Johnson seconded Supervisor Lawyer's motion, and it was unanimously carried, and the Chairman was authorized to sign Agreements for Contracts "A" and "B" with low bidders as recommended. Supervisor Johnson then asked the Chairman to allow him to leave his seat and step before the microphone to address both the Board and the many people present in the Chambers; the Chairman so acknowledged his request, and Supervisor Johnson delivered the following message to Supervisor Lawyer:

"We cannot tell you how delighted we are that you, as Senior member of this Board, have made the motion for us to let the contract for this long dreamed-of Administrative Center;

"County officials and private citizens named on this list wanted to commemorate this occasion with some type of gift for you.

"I have looked high and low for a big needle, but in my estimation, I could not find one large enough or sharp enough;

"Then, it was thought that a very large gavel would be appropriate which would signify your outstanding leadership not only in your District, but in this County, and we decided there wasn't one large enough to match that leadership;

"Next, we thought some type of device to derail the South Lake Tahoe-Shingle Springs Railroad would be appropriate, but I decided against that.

"Now, you will remember in November we asked you to bring in your big leather hat and we got Dick Stanfield to take some pictures of you --- well, we have one blown up into life size, but that didn't turn out very good;

"Anyway, we have to have something of substantial size to represent our affection and admiration of you, and something equally large to represent your outstanding leadership and devotion to this County - - -

"So now we are about to present you with something we think fills all these requirements, commissioned to be done by one of your own constituents -- CHIP FYN!!"

At that point, a 300-pound wood sculpture of Supervisor Lawyer was wheeled into the Chambers amid much applause and not a few tears. Supervisor Lawyer acknowledged this gift with enthusiasm; thanking each and every one in his usual candid and sincere manner.

Supervisor Lane then stepped forward to recite the following poem which he had composed for Supervisor Lawyer, and entitled, "El Dorado's Lawyer":

It was about nine years ago, or ten
When a previous Supervisor did yen
For a higher political seat to take
A seat in the Capitol the voters did make

Leaving the County, District Number Four Chappie turned toward the Capital door And the vacancy created on that day Was destined to be available for Ray

The then Governor chose the best, yes sir
District Four's seat was given to Lawyer
Respected by constituents, great with pride,

- 9. Subject to being marketed only as an "adult" community.
