Assembly Bill 66: Eliminates the requirement of filing fees to be paid by candidates for public office, and provides that nomination papers of any candidate for public office must contain signatures equal to one-half percent of the reigstered voters eligible to vote for that office as of January 1st of the filing year;

Assembly Constitutional Amendment 21: Removes the non-partisan status of supervisors, councilmen, and mayors from Section 5 of Article II, State Constitution, while retaining the non-partisan status of judicial and school officials. Furthermore, all elective county and city offices other than supervisor, councilman, and mayor, retain their non-partisan status.

Senate Bill 231: Allows a county, city, or district to conduct an advisory election in consolidation with scheduled local elections allowing the voters within the local jurisdiction to voice their opinions on substantive issues (not defined) or to indicate whether or not they approve the proposal appearing on the ballot.

On motion of Supervisor Lane, seconded by Supervisor Walker, and unanimously carried by those present, the request was referred to County Counsel and the Assistant to the Board to prepare opposition letters to the appropriate State legislators, containing the County Clerk's comments on AB 66; ACA 21; and SB 231.
