The City cannot, at this time, determine whether this project is affected by such regulations. The legality of the C.T.R.P.A regulations has not yet been resolved, nor has the permitted scope and application of the same been determined."

County Counsel submitted a letter suggesting that each time CTRPA is referred to, TRPA be additionally referred to.

After discussion, the Board, on motion of Supervisor Johnson, seconded by Supervisor Walker, and carried by the following vote: Ayes: Supervisors Johnson, Walker, and Stewart; Noes: Supervisors Lane and Kutter, the Statement was approved with the addition of County Counsel's suggestion that each time, within the Statement itself, that CTRPA is referred to, that TRPA also be referred to.

Communication was received from the Affiliated Seniors of El Dorado County requesting authorization and funds for transportation and lodging to send their Secretary to the Western Conference on Rural Housing to be held in Denver, Colorado, on October 21-23, 1975.

On motion of Supervisor Johnson, seconded by Supervisor Lane, and unanimously carried, the request was denied.

Petition was received containing 155 signatures requesting reduction of the speed limit from 45 MPH to 30 MPH on Pony Express Trail, between The Apple House and Bill Kopler's Store (Snowline Road).

On motion of Supervisor Lane, seconded by Supervisor Johnson, and unanimously carried, the matter was referred to the Traffic Advisory Committee with the request that they take into consideration that it was formerly a highway with greater traffic loads; and that it may have a traffic build-up on it which could have a reverse effect.

James J. Jordan, Program Director, Tahoe Regional Planning Agency's Areawide Waste Treatment Management Program, was present in support of his letter of September 26, 1975, requesting Board consideration of the development of a nursery and greenhouse on lands possibly adjacent to the Lake Tahoe Airport for the purpose of growing native shrubs for revegetation. He showed slides depicting various stages of erosion in certain areas of the Lake Tahoe Basin, and advised the Board that TRPA, through a cooperative effort with a number of other agencies, was initiating a grant request to the federal Energy Resources Development Administration to see if funds would be available to assist in developing a nursery utilizing solar energy to grow native plant materials for erosion control.

On motion of Supervisor Johnson, seconded by Supervisor Stewart, and unanimously carried, the Board authorized the use of the Lake Tahoe Airport property as a site for their nursery; said site to be at the discretion of the Airport Manager, and requested that the matter be brought back to the Board for a formal agreement at a later date.
