- 1. The railroad tracks would have to be realigned.
- Construction of the proposed frontage road would not improve the two intersections.
- 3. Very little of the existing State highway could be used in the realignment.

He further stated that if this alignment were approved by the State, the two existing Carson Road connections should be closed and a new connection be constructed opposite Camino Heights Drive at the location of a future interchange, and that the State Department of Transportation has estimated the cost at between \$750,000.00 and \$1,000,000.00.


