- 3. It was stated that the church congregation convened only twice a week and therefore would not disrupt the neighborhood insofar as noise level is concerned; and
- 4. It was stated that a parking lot on the property would be available for the congregation, thereby obviating any on-street parking.

Mr. Donald Haney, property owner, was present and opposed to the Use Permit. Mr. Otto Stortz, donor of the property to the Church, stated that he intended to leave the balance of his property (which adjoins that already donated) to the Church upon his demise.

No other protests were received.

Supervisor Kutter's motion to uphold the ruling of the Planning Commission and their findings, with the additional finding that the adjoining land-owners consider the proposed use as detrimental to the neighborhood, failed for the lack of a second.
