On motion of Supervisor Kutter, seconded by Supervisor Johnson, and unanimously carried by those present, the Chairman was authorized to sign the Airport Use Agreement, after the following changes have been made: the words "written approval" have been added to Line 21, Page 1, between the sixth and seventh word; and the words "Federal Aviation Administration and Civil Air Administration" have been added between the first and second wordson Line 15, Page 4, plus an additional paragraph to be added by County Counsel to the effect that the County shall be allowed to remodel without paying an inconvenience fee to the airline -- also, included in the motion was the adoption by the Board of RESOLUTION NO. 85-77 Fixing Rates and Charges on County Airports for Airlines, and the approval for Chairman's signature of the Amendment of Lease and the Terminal Space Lease.

The Board informally continued to April 26, 1977, the Airports Director's request for approval of a revised budget for the 4th quarter of Fiscal Year 1976-77 to readjust line item accounts to cover necessary expenditures not previously anticipated.

The Board again considered a procedure for the allocation and distribution of construction permits in the South Lake Tahoe area during the 1977 construction year as it would apply to any building or structure which requires a new sewer permit or results in a demand for additional sewer units due to the limited capacity within the South Tahe Public Utility District sewage treatment plant.

Lorraine Kashuba, Gary Kluckhuhn, and John Hubble were present and urged the Board to support the Citizens Committee's Allocation Plan and Proposals which had been submitted for the Board's review.

At the recommendation of Bob Karrasch, County Sanitarian at Lake Tahoe who worked on this problem with the City of South Lake Tahoe and the Citizens Committee, the Board, on motion of Supervisor Johnson, seconded by Supervisor Todd, and unanimously carried by those present, rescinded their action of April 5, 1977, which approved in concept, the procedures submitted by the City of South Lake Tahoe, and in turn, adopted in principle the Plan submitted by the Building Permit Allocation Plan Committee (Citizens' Committee). (Said Allocation Plan is on file in the Board of Supervisors Office). (The procedures submitted by the City of South Lake Tahoe on April 5, 1977, to the Board involved a lottery system whereby all construction permits for residential units were to be placed in a series of six drawings held at three-week intervals throughout the construction year -- See Minute Book 18, Page 144).
