City of South Lake Tahoe presented drawings of the proposed landscaping North Lake Tahoe.

On motion of Supervisor Johnson, seconded by Supervisor Kutter, and unanimously carried by those present, the Board authorized that the Library at South Lake Tahoe be painted as soon as feasible, and that the color be coordinated with City Hall.

Attorney David Combellack was present on behalf of the Ajapa Yoga Foundation, Inc. and expressed the opinion of the Foundation that once the Appeal was withdrawn, there was no Appeal before the Board. He further stated that it was his belief that the Board had no jurisdiction in this case.

Harry Ludlam, a resident of the area, stated that the Uniform Building Code refers to a "family" as a group of not more than five persons who need not be related by blood or marriage, living together in a dwelling unit. (See Minute Book 18, Page 230, re: "family")

Others present and opposed to the Appeal were: Bob Nelson; Roland Cook, who spoke of the deteriorating effect of numbers of people on the access to the property which is by a steep, rocky road which crosses a narrow bridge; Josh (?) Vervalle, who requested that the Board declare that they have jurisdiction in this matter, or else turn the matter back to the Planning Commission for another hearing.

At this point the Deputy County Counsel advised the Board that she did not believe that the Board would have a good case, insofar as jurisdiction is concerned. The Board then recessed for an executive session with Deputy County Counsel.

The Board reconvened and the Chairman declared that the Board would take no action on this matter.

At the recommendation of the Planning Commission, on motion of Supervisor Kutter, seconded by Supervisor Stewart, and unanimously carried by those present, the request of the Engineer for Pilot Hill Estates Unit No. 3 for a variance to the grade requirements for roadways as required in the County's Draft Design Manual, was approved.

GENERAL ORDERS

On motion of Supervisor Stewart, seconded by Supervisor Kutter, and unanimously carried by those present, the Board declared their intent to act in unison with the City of South Lake Tahoe in requesting the Building Department to not accept any more applications for building permits for single family dwellings in the unincorporated area of South Lake Tahoe.

On motion of Supervisor Stewart, seconded by Supervisor Kutter, and unanimously carried by those present, the Board approved the request of the Welfare Director to waive the \$800.00 institutional placement limit, and place a 10-year old child in the Sacramento Treatment Center's Auburn unit, at a monthly cost of \$963.00.

On motion of Supervisor Stewart, seconded by Supervisor Todd, and unanimously carried by those present, the Chairman was authorized to sign the letter to the California Tahoe Regional Planning Agency, as drafted.

Project Director, County Nutrition Program for the Elderly, submitted a letter stating that the Purchasing Agent received no bids on the project to remodel the County Senior Nutrition Program's central kitchen with State funds which must be encumbered by the end of June, or they are lost.
