BOARD OF SUPERVISORS MINUTES\_\_\_

The Board convened in a continued meeting, from June 17, 1980. Present: Supervisors Arliene Todd, William V. D. Johnson, and Thomas L. Stewart. Dixie L. Foote, Assistant Board of Supervisors Clerk, was also present. Supervisors Walker and Flynn were absent. Chairman Todd presided.

With the Board convened as the Board of Directors of County Service Area No. III, a hearing was held as duly advertised to consider a \$5.00 service fee to be imposed on improved parcels within County Service Area No. III for mosquito abatement purposes.

Mr. Glenn E. Bissell, Managing Entomologist, and Mr. Kim Oyler, Field Supervisor, representing County Service Area No. III, were present and spoke to the technical aspects of mosquito abatement and the costs involved.

Director Stewart pointed out that the Board of Directors can hold a public hearing and re-set the fee yearly. It does not have to be \$5.00 per parcel every year -- it can be less, but not more than that amount.

Mrs. Pat Lowe, resident of the area, was present and asked why the fee is not levied against unimproved parcels also, since there is so much unimproved land at Lake Tahoe. Director Stewart advised her that County Counsel does not believe the County can legally do so, because this is a service to people which must be paid for by the people served.

Mr. Eugene Louis, who resides on Lot 401 in Unit 21 of Tahoe Paradise, was present and stated he has no objection to the \$5.00 fee as long as he sees some results. Mr. Louis acknowledged that the mosquito problem is severe, and would not object to paying \$10 or \$15 a year if it will result in a solution to the problem.

Mrs. Pat Lowe also inquired whether the County has an agreement with the U.S. Forest Service for a joint effort in dealing with the mosquito abatement problem. Mr. Bissell replied that the County does not have such an agreement, however, Forest Service lands are treated if they are adjacent to a problem area that is being treated for the benefit of the residents in that particular area.

There were no written or verbal protests, and the hearing was closed.

On motion of Director Stewart, seconded by Director Johnson, and unanimously carried by those present, the Board approved the fee of \$5.00 per improved parcel, within the boundaries of County Service Area No. III, as the assessment this year for mosquito abatement; and RESOLUTION NO. 196-80 was adopted accordingly.

There being no further business to come before the Board of Directors of County Service Area No. III, the meeting was adjourned to Tuesday, June 24, 1980, at 10:00 a.m., at which time the Board will convene for its regular meeting as the Board of Supervisors.
