Hearing was held as duly advertised (continued from October 26, 1982) to consider an application for a license to operate a card room at 4122 Cameron Park Drive, south of Highway 50, in Cameron Park, petitioned by Kenneth and Leota Bergstrom and Cecelia Bonaudi.

Mrs. Leota Bergstrom was present and spoke to her request. Also present to speak in favor of the request was Mrs. Karen Guthrie, attorney representing Mr. and Mrs. Leslie Anderson, landlords of the building wherein the proposed card room will be located.

There were no verbal protests, and the hearing was closed.

In a letter dated November 23, 1982, the Sheriff advised that the applicants have no criminal history and are, therefore, of good character; however, the Sheriff's Department feels it would not be wise to allow this card room in the location proposed as there is already a bar (The Alibi Room) in the same building complex which creates numerous law enforcement problems. (The proposed card room will include a beer and wine bar for its patrons.)

In a letter dated November 15, 1982, the County Planning Director advised that he has no objection to the proposed card room, provided that on-site parking spaces are provided in accordance with the following ratio:  
4 tables x 8 persons = 32 parking spaces, plus 1 parking space per employee.

In a letter dated November 5, 1982, the County Building Official recommended that, before the cardroom license is issued, the following requirements should be met: (1) application and issuance of a building permit; (2) sanitary facilities to code; and (3) professional analysis of ventilation system, with all work required to be performed with a building permit.

In a letter dated November 9, 1982, Cameron Park Fire Chief Richard Samples outlined fire code requirements that must be met, prior to occupancy, regarding exits, maximum occupancy, drapes and decorative materials, and fire extinguishers.

The Airport Land Use Commission advised it has conditionally approved Special Use Permit No. S81-32, requested by the Northern California Conference of Seventh-Day Adventists, which allows a non-commercial aircraft landing field (daylight operations only) and a recreational vehicle parking area, to be located in Leoni Meadows, on both sides of Caldor Road, four miles east of Grizzly Flat; and requested the Board adopt a Resolution approving same.

On motion of Supervisor Flynn, seconded by Supervisor Dorr, and carried by the following vote: Ayes: Supervisors Dorr, Walker, Flynn, and Stewart; No: Supervisor Lowe, the Board adopted RESOLUTION NO. 5-83, resolving that it has reviewed the application for a private, non-commercial aircraft landing field submitted by the Northern California Conference of Seventh-Day Adventists, and approves same based on the following findings:

1. The private landing strip is compatible with the existing land use designation and densities as shown on the County General Plan (Timber-Seasonal Recreational-Residential);
2. The proposed project site is currently under Special Use Permit No. S75-45, establishing a church camp retreat which includes recreational facilities (boating, swimming, camping and horse related activities) and dormitories;
3. The establishment of height limitations are not necessary since height limitations are established by the County Zoning Ordinance;
4. Further review of the landing strip must be conducted by the California Division of Aeronautics for public health, safety, and welfare and operational permits; and
5. The County Planning Commission has approved the land strip by Special Use Permit No. S81-32.


