At the recommendation of the Community Development Director, and on motion of Supervisor Dorr, seconded by Supervisor Flynn, and unanimously carried, the Chairman twas authorized to sign a letter, to be signed by representatives of the City of Placerville, El Dorado County, and the Local Transportation Commission and sent to the State Department of Transportation, in response to the State's letter regarding the mitigation project on Route 49 as a condition for programming the Route 50 Government Center Interchange.

At the recommendation of the Community Development Director, and on motion of Supervisor Stewart, seconded by Supervisor Flynn, and unanimously carried, the Chairman was authorized to sign an amended, 10-year, Joint Powers Agreement with the Lake Tahoe Unified School District for use of 1980 State Park Bond funds, in the amount of \$10,000.00, for a sports field re-sodding project at the Meyers Elementary School.

ORDINANCE NO. 3505 was adopted, on motion of Supervisor Walker, seconded by Supervisor Flynn, and unanimously carried, amending Section 15.16.100 of the County Ordinance Code which allows a "record" permit only for placement of non-hazardous, non-inhabitable, agricultural buildings, in A, AE, and U Zones, to expand this fee-exempt category to allow such structures in any zone allowing agricultural use. On motion of Supervisor Flynn, seconded by Supervisor Walker, and unanimously carried, an Ordinance was introduced to amend Section 15.33.050 of the County Ordinance Code to more accurately reflect the method of resubdivision of Auburn Lake Trails Subdivision, as requested by the Georgetown Divide Public Utility District; the reading thereof was waived; and it was continued to December 11, 1984, for adoption.

RESOLUTION NO. 370-84 was adopted, at the request of the Georgetown Cemetery Trustees, and on motion of Supervisor Flynn, seconded by Supervisor Dorr, and unanimously carried, calling for an election, to be held on February 5, 1985, within the boundaries of Zone No. 3 of County Service Area No. 9, on the guestion of levying a special tax, in an annual amount not to exceed \$10.00 per improved lot and \$3.00 per unimproved lot within said Zone, to operate and maintain two public cemeteries.

On motion of Supervisor Flynn, seconded by Supervisor Dorr, and unanimously carried, the Board authorized Mr. Glen Coit to record the final map for Royal Heights Townhouses No. 3 Subdivision, prior to the paving of Heights Drive; said authorization subject to the approval of County Counsel and the Department of Public Works, and contingent upon Mr. Coit posting a bond in the amount required in the County Ordinance Code prior to the recordation of the map.

On motion of Supervisor Dorr, seconded by Supervisor Walker, and unanimously carried, the Public Works Director was requested to review the matter of utility companies tearing up County roads to access their facilities and then not patching the roads in a timely manner or, if the patches sink, not repairing them in a timely manner; and report back to the Board on December 11, 1984, as to how this problem can be resolved.

In response to a citizen's complaint that vehicles, particularly garbage trucks, are travelling too fast on Union Mine Road, the matter was referred to the Traffic Advisory Committee for its recommendation regarding a possible reduction of the speed limit on Union Mine Road; on motion of Supervisor Walker, seconded by Supervisor Dorr, and unanimously carried.
