Community Development Department submitting its report on proposed revisions to the 2010 General Plan Program, and proposed amendments to the contract with Sedway Cooke Associates; and recommending the following:

- 4. Direction to staff to develop a Request for Proposal (RFP) for a west slope inventory and analysis of natural resources to be mapped in a format compatible with a future G.I.S.; <u>BOARD ACTION</u> - Board approved the alternative as presented to the Board this date by the Community Development Department staff, at a cost of \$40,000, said alternative will include the update and field verification of the "Goudey maps" and the reconstitution of missing maps.
