**HEARING TO CONSIDER THE 1992-93 COUNTY BUDGET**

**BOARD ACTION** - Hearing continued to Tuesday, September 15, 1992, to receive the Chief Administrative Officer's (CAO's) analysis of issues raised in the budget hearing September 8 through 11, 1992.


On September 15, 1992, the Board continued the budget hearing to Thursday and Friday, September 17 and 18, at 9:00 a.m., for final "wrap up" of unresolved issues.

On September 18, 1992, the Board closed the hearing on the 1992-93 County budget based on the CAO's memorandum regarding final budget adjustments, dated 9/15/92, the Board's review of that document on 9/17/92, and ratification of the CAO's two-page summary of those activities entitled, "Final Budget Changes as of September 17, 1992" as modified this date to reflect a total General Fund Budget of \$101,851,042; and staff was given direction that if, upon legal review, the General Fund contribution to County Service Areas could be reported as General Fund dollars vs. property tax increment allocations, it will be done.
