A change clarifying the presence of three board members <sup>1</sup> is required.

# 210. Powers & Duties.

Various changes relating to the Board's powers of appointment and removal, and as to the appointment of the Superior and Municipal Court's executive officers.

### 211. Communications with Employees.

Clarifies a Supervisor's right to obtain information and request assistance or advice.

## 407. Agricultural Commissioner.

Change to reflect the consolidation of the Offices of the Agriculture Commissioner and Sealer of Weights & Measures.

# 702. General Law Governs.

Changes to clarify the relationship of charter provisions to existing law.

## II. Alternative Amendments for Voter Consideration

#### 202. Term of Offices.

A change to limit terms for supervisors to two (2) consecutive terms.

### 210(c). Powers and Duties.

A change to require voter approval for any new or increased benefit assessments.

### 407. Agriculture Commissioner.

A change to reflect the consolidation of the Agriculture Commissioner and Sealer of Weights & Measures and to provide for appointment/removal in accordance with general law.

# 408. Probation Officer.

A change to provide appointment/removal of the Probation Officer in accordance with general law.

**BOARD** ACTION - Staff authorized to proceed with the promulgation of the proposed County Charter set forth in the draft form dated July 13, 1994, with changes approved by the Board this date\*, to be included on the ballot for the November 1994 election; and County Counsel authorized to refine the language identifying the "side bars" (Amendments). NNuBCU

\*Corrections made this date to the proposed County Charter dated July 13, 1994:

## Section 202 Terms of Offices (Pg 7)

Corrected to read, "<u>The supervisor for each of the First,</u> <u>Second and Third Districts shall be elected in 1996. The</u> <u>supervisor for each of the Fourth and Fifth Districts</u> <u>shall be elected in 1994.</u>" Section 211 Communications with Employees (Pg 11)

Corrected to read, "<u>Board of Supervisors' directions</u> recommendations or instructions to boards, commissions, <u>department heads or officers shall be by formal Board</u> action. This section does not limit an individual <u>Supervisor's right to obtain information or request</u> advice or assistance in accordance with normal operating policies."

Section 602 Contract Administration (Pg 21)

First sentence of said Section corrected to read, "The Board of Supervisors shall not authorize the payment of money or other compensation for the performance of any service or function by a private entity except pursuant to a written contract meeting all legal requirements for county contracts as set by the Board."

Section 702 General Law Governs (Pg 22)

First sentence of said Section corrected to read, "<u>Unless</u> otherwise set forth in this charter, the general laws set forth in the Constitution of the State of California and the laws of the State of California shall govern."

In a second motion, the Board approved for inclusion on the November 1994 ballot, the following three "Alternative Proposed Amendments (side bars) to the El Dorado County Proposed Charter": NCBNuU

**Section 202 Terms of Offices -** said Amendment provides for **term limitations** for members of the Board of Supervisors;

Section 407 Agriculture Commissioner/Sealer of Weights & Measures - provides for consolidation of the offices and appointment and employment for said Officer as provided for by general law;

**Section 408 Probation Officer -** provides for the appointment and employment of said Officer as provided for by general law.

In a third motion, the Board approved for inclusion on the November 1994 ballot, the following Amendment (side bar): CBNuNU Section 210(c) Powers and Duties - amending the language of said Amendment from that approved in concept on 7/12/94 to read, "Increases to current benefit assessments on real property, or the imposition of any benefit assessment not previously imposed on real property shall not be effective unless and until approved by a majority of the voters voting in the geographic area in which the assessment will be imposed. A continuation of a previous benefit assessment in the same or lower amount is not covered by this section. This requirement does not apply to special taxes, any assessments imposed by a special district, or any assessments required to pay bonded indebtedness. The voting requirements shall only apply to County benefit assessments on real property, and shall not apply to taxes imposed by any special district."

In a fourth motion, the Board requested the CAO to report to the Board on the cost involved in distribution of the proposed County Charter, prior to distribution of sample ballots, and to explore whether local newspapers would be willing to publish same at no cost to the County. NBNuCU
