#### DEPARTMENT MATTERS

- The twenty-seven (27) litigation cases and claims be reviewed with specific access granted to the Treasurer-Tax Collector acting as an agent of the Board and the Board's expression of its intent not to waive the attorney-client or other applicable privileges;
- The Board give specific instruction that applicable privileges be maintained by the Treasurer-Tax Collector concerning information obtained in her review of the subject files; and
- Direction that if additional claims and case file review is desired for the Treasurer-Tax Collector's report, the matter be brought back for specific Board authority.

Supervisor Nielsen made a motion, seconded by Supervisor Nutting, to amend Supervisor Upton's motion to authorize the Treasurer-Tax Collector access to those files of the County Counsel that are subject to Risk Management undertakings, further reserving to County Counsel the right to decline to make available those files that, in his opinion, have a special statutory privilege attached to them, with the understanding that any disagreements between County Counsel and the Treasurer-Tax Collector regarding same would be brought back to the Board for final resolution.
