A. Bond Screening Committee reporting on the REDIP process; <u>BOARD ACTION - RESOLUTION NO. 21-95</u> adopted as amended, a Resolution conceptually approving an application for the REDIP Loan, with Section 3 of said Resolution amended to read: "The County Chief Administrative Officer is hereby authorized to complete preparation of a draft application and submit same to the State, and to place the draft application on the **January** 24, 1995, Board of Supervisors Agenda for Board approval and authorization for the Chairman to execute the final application.". County Counsel authorized to bring back to the Board on **January 24, 1995**, the form of security agreement or implementing documents which will contain alternatives as far as designation of the areas of benefit. UBNuNS
