TRANSPORTATION DEPARTMENT (Tapes 1 & 2)

Board affirmed the 1996/97 budget for the Transportation Department with the record showing no change with regard to the \$71,000 loan to the Airport Enterprise Fund described on page 108-A3 of the Budget Addenda; said action without prejudice to further review of the character of the loan. HEALTH DEPARTMENT (Tapes 2 & 3)

Board approved the CAO's recommendations regarding the County Service Area (CSA) 7, Ambulance Service, 1996/97 budget as set forth in his memorandum to the Board dated September 13, 1996, allowing a transitional budget pending formation of a Joint Powers Authority (JPA) to provide ambulance and ambulance dispatch IIservices for the County; and approved the 1996/97 Health Department budget with the following appropriations budgeted with a proviso the funds not be expended without direct authorization of the Board of Supervisors:



- \$18,915 1995/96 administration costs supporting Health Department activities on behalf of CSA 7.
- \$56,972 Special Department Expense monies set aside for possible adjustments during the transition to a County-wide fire department JPA providing ambulance and dispatch services.
- \$ 5,820 1995/96 administration costs supporting Health Department activities on behalf of CSA 3.

Included in the motion is the Board's request that the Health Department report back with a breakdown of the \$29,850 charged directly to ambulance programs (CSA 3 and CSA 7) in the 1996/97 budget for services provided to ambulance programs by the Health Department Central Administration.
