- 2. Public Health Department authorization to apply for State Department of Health Services funding for local tobacco control interventions targeting young adults. RECOMMENDED ACTION: Approve.
- 3. General Services Department recommending Amendment 001 to Agreement 373-S0011 with the County of Madera increasing the not to exceed amount to \$135,000 for a term to expire March 31, 2002 for housing juvenile court wards for the Probation Department. RECOMMENDED ACTION: Authorize Chair to sign. DBBaHS
- 4. General Services Department recommending Amendment 001 to Agreement 347-S0111 with Marjorie Hill increasing the not to exceed amount to \$44,720 for a term to expire June 30, 2001 for selected janitorial services for the Mental Health Department. RECOMMENDED ACTION: Authorize Chair to sign.
- General Services Department requesting authorization increase the blanket purchase order issued to Walker's Office Supplies for desktop office supplies for period ending May 22, 2001, (Bid #615-048), from \$300,000 to \$450,000 and, pursuant to Board Policy C-4, advising it will extend said bid for one year in the amount of \$450,000 for period May 23, 2001 - May 22, 2002.

Approval not granted; however, Board authorized an additional \$40,000 on the existing blanket purchase order to Walker's desktop office supplies; General Services Department stated its intent to issue blanket purchase orders in the amount of \$5,000 each to Staples and Office Depot at South Lake Tahoe; and the matter of purchase of desktop office supplies was continued to April 3, 2001. 6. General Services Department requesting authorization to modify blanket purchase orders with Diamond Pacific and Norcal Electric.

RECOMMENDED ACTION: Approve the increase of each from \$9,900 to \$20,000.

7. El Dorado County Agricultural Commission recommending Transportation Department be authorized to issue an obstruction encroachment permit for six Fair Play Viticultural signs to benefit the agriculture area and provide safety of travel.

RECOMMENDED ACTION: Approve.

50. Public Health Department requesting authorization to release the Request for Proposal (RFP) for ambulance services in County Service Area 003. (Continued 3/13/01, Item 83)

BOARD ACTION - Board authorized release of the RFP and Addendum today and amendment of the Emergency Medical Service (EMS) Plan to be consistent with the RFP and on the subject of inter-facility transfers, selected Option 2, the status quo on a single 911 provider with open competition for inter-facility transports because decisions on inter-facility transport should be made by hospital personnel, whether it be nurse or doctor, because patient care is critical; motion as clarified by County Counsel allows the County, as the provider of services, or through its contractor to engage in that open competition for inter-facility transfers.

51. Administration submitting two options for the apportionment of net operating costs of El Dorado County's Local Agency Formation Commission (LAFCO):

Option 1: Implement the funding mechanism in Assembly Bill (AB) 2838 which provides for the County, cities, and special districts to each fund one-third of the net operating expenses of LAFCO beginning with the 2001/2002 fiscal year; (Interim Chief Administrative Officer recommending this option) or

Option 2: Direct staff to negotiate an agreement with the cities and special districts which varies from the one-third method of apportionment. (Continued 3/6/01, item 54)

BOARD ACTION - Board approved Option 1, implementation of AB 2838 funding mechanism. DBBaHS

- 52. Reconsideration of interpretation of Measure Y Issue 7 "Cumulative impact, which includes latent demand, must as a matter of policy be considered when establishing a road plan and fee under Policy 3.2.2.4 which says cumulative impacts nor latent demand are mentioned in Policy 3.5.1.6.1 and therefore are not part of Policy 3.5.1.6.1". (Continued 3/13/01, Item 82)

 BOARD ACTION Board acted as follows: BaBDH S(n)
 - (1) Re-adopted original Measure Y interpretation for Issue #7 (on 12/7/99) as follows: "Policy 3.5.1.6.1 requires consideration of the direct impacts of the project along with future development of latent demand (i.e. development of existing parcels or projects which have already obtained discretionary approvals)."

- Directed County Counsel's office to conduct an (2) assessment of all previously-approved ("latent demand") projects, and report back to the Board on April 24, 2001, at 10:00 a.m., regarding the General Plan traffic policies these projects are obligated to comply with, and what discretion the County has in requiring these projects to comply with "No level of service F" (NO LOS F) policies. Some types of "previously-approved projects" are: Final Parcel Maps - single family residential, multi family, and non-residential; Plans, Tentative Maps and Development Agreements LOS F exemption; and Specific Tentative Maps and Development Agreements without LOS F exemption.
- Directed County Counsel's office, with Department (3) of Transportation's (DOT's) assistance, to begin research on constructing State Highway (Traffic Impact Mitigation) Fee Model which would vary, depending on peak-hour U.S. Highway 050 commute traffic patterns, within the different Directed the Interim Chief County regions. Administrative Officer (CAO) to bring back to the Board on April 3, 2001, professional services contracts deemed necessary to complete this task, if any, and further directed the CAO to find funding for these professional services contracts from within current appropriations.
- (4) Directed County Counsel's office, with DOT's assistance, to construct a Measure Y traffic monitoring system that provides up-to-date data regarding current and cumulative Levels Service (LOS) on County roads and highways to help determine when new 5+ residential projects can go forward. Directed the CAO to bring back to the Board on April 3, 2001, professional services contracts deemed necessary to complete this task, if any, and further directed the CAO to find funding for these professional services contracts from within current appropriations.

- 53. Supervisor Baumann recommending the following pertaining to the implementation of Measure H, the Vehicle License Fee Initiative:
 - (1) Direct County Counsel to proceed no further with the litigation initiated by the County last year to invalidate said Measure, which was passed by the voters in November, 2000;
 - (2) Direct Interim Chief Administrative Officer to include in the fiscal year 2001/2002 proposed budget and in each subsequent year's budget a \$1,500,000 operating transfer from the General Fund to the Road Fund; and
 - (3) Direct the Department of Transportation (DOT) to prepare a written recommendation as to how the additional \$1,500,000 should be utilized during fiscal year 2001/2002, including a list of specific maintenance projects proposed for same.
 - BOARD ACTION Having noted that the Board met in March 13. 2001, closed session on regarding recommendation #1 and reported out that approval of Supervisor Baumann's recommended direction to County Counsel, and having heard from the Director of Transportation regarding recommendation #3 that utilization of the Measure H funding will be itemized in DOT's 2001/2002 Proposed Budget, the Board today approved recommendation #2 for the 2001/2002 fiscal year only, and directed that on an annual basis we hold in a separate account the monies that the County would be receiving on the vehicle license tax so that we can keep that amount clear and see where it is going, and that there be yearly recommendations from DOT as to how those specific monies will be spent. - 54. Supervisor Dupray recommending \$30,000 be transferred from General Fund Contingency to the Library to retain services of a consultant for completion of a needs assessment for construction of the proposed new library in El Dorado Hills. (Continued 3/13/01/# 54)
