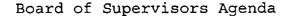

- Pacific Gas and Electric Bankruptcy Filing, U.S. Bankruptcy Court, Northern District of California, San Francisco Division, No. 01-30923-DM; and BOARD ACTION - By unanimous vote, the Board authorized a settlement of claims for penalties in this matter dealing with property taxes: under the terms of the settlement, Pacific Gas and Electric will pay 100% of the base property tax owed and will agree to pay a 10% penalty on the portion of the property tax paid after the delinquency date of April 10th resulting in the payment of all base property taxes owed and slightly less than 50% of the penalties which are owed.
- Heavenly Valley, et al vs El Dorado County Board of Equalization, et al, Case PV004876.
 BOARD ACTION - By unanimous vote, the Board authorized filing of an Appeal in this matter, subject to an ultimate determination by County Counsel after further review.

Section 54956.9(b), Anticipated litigation:

- Significant exposure to litigation. Title: County Review of Vested Status of Counsel Approved Development Projects (Continued 7/10/01); Counsel advised the public in regard to the specific project referred to as the Valley View Project -White Rock Village phase, that the Board took no action, basically declining to take a position which adverse to proceeding with the Development is Agreement: in other words, the Board is not seeking to challenge or interpret the Development Agreement other than is stated in the language; and further advised that the effect of taking no action is that staff will simply process those building permits in accordance with the Development Agreement.
- Lake Tahoe Ambulance, Inc. vs County of El Dorado; and BOARD ACTION - By unanimous vote, the Board authorized the retention of the law firm of Preuss, Shanagher, Zvoleff & Zimmer, to both advise the Board and provide representation in the event of potential litigation regarding the ambulance award process, and further authorized the Chairman to execute a contract prepared by Counsel Counsel for same.
