BOARD ACTIONS (on September 14, 2001):

Board considered recommendations 1 through 15 presented by Supervisor Baumann this date (refer Exhibit "A" attached hereto), and approved the recommendations with modifications, clarifications and additions noted thereon and/or below: BaDBHS

Modifications/Clarifications:

- Risk Management personnel allocation on page 9 of the #3 Proposed Budget corrected to reflect changes approved by the Board prior to the budget hearing, i.e., two (2) Sr. Risk Management Analyst positions and one (1) Risk Management Analyst I/II and a change being requested at this time to increase the Sr. Fiscal Assistant position allocation from .75 to .80.
- #9 removed for separate action of the Board.
- #10 Deletion of the \$60,000 appropriation for "General Fund Other Operations - Regional Cooperation" was modified to reduce the appropriation by \$50,000 leaving \$10,000 specifically appropriated for the County's contribution to the "Strategic Action Plan for the Airport Economic Benefit Partnership" comprised of representatives from El Dorado County, Douglas County (Nevada), the City of South Lake Tahoe, Lake Tahoe Visitors Authority and South Lake Tahoe Chamber of Commerce.

Additions:

- Creation of a new "Budget Reconciliation Account" within Department 15 with the net amount available to the Board after final budget adjustments; said account to be a secure fund to be used at the Board's discretion.
- Recognition of a need for funding in the amount of approximately \$200,000 for equipment and operational costs for an enhanced snow removal pilot program.

- General Services Department to study further its proposed allocation of one (1) FTE Facilities Sr. Project Manager position and not fill same until authorized by the Board at a later date to do so.
- Board of Supervisors Department to delay filling the vacant Deputy Clerk of the Board II position until staff organization can be further reviewed.
- Funding authorized to send two (2) representatives of County fire districts and two (2) representatives of the Sheriff's Department (if needed) to attend the memorial service on the east coast to honor fire fighters and police officers lost in the terrorist attack on the city of New York and Washington D.C.
