BOARD ACTION - At the request of Sheriff-Elect Neeves and the recommendation of the Interim CAO, the Board directed that the Sheriff's Department be given credit for State "rural counties" funding adjustments for fiscal years 2001/2002 and 2002/2003 in the amount of \$896,812 and credit for retirement payout costs in the amount of \$180,000 leaving the department with a net County cost target of \$23,919,000 for 2002/2003, thereby a target reduction from here on out of \$307,000, and the Interim CAO was directed to continue working with Sheriff's Department staff to accomplish same.
