The proposed actions are: modify existing Rule 213, Storage of Petroleum Products; remove existing Rules, Rule 215-Architectural Coatings; Rule 216-Exemptions to Rule 215 and Rule 217-Identification of Coatings; adopt new Rules, Rule 215-Architectural Coatings; Rule 216-Organic Compounds, and Rule 217-Acid Fumes.
