ADOPTION OF THE AGENDA AND APPROVAL OF MINUTES FROM FEBRUARY 23, 2022, AND MARCH 30, 2022.

A motion was made by Melinda Peak, seconded by Nichole Jordan to approve the Agenda and Minutes. The motion was approved unanimously.

DISCUSSION ITEMS

1) Approval of the meeting format (virtual) for the June 22, 2022, meeting of the Cemetery Advisory Committee. The committee recommends, as a result of ongoing concerns related to COVID-19, to approve the following teleconference finding pursuant to Government Code subsection 54953(e)(3) in order to allow for the continued use of virtual committee meetings as authorized under Assembly Bill 361. Pursuant to Government Code subsections 54953(e)(3)(A) and (e)(3)(B)(ii), the committee has reconsidered the circumstances of the state of emergency resulting from COVID-19 and the El Dorado County Public Health Officer continues to recommend measures to promote social distancing, as documented in the September 30, 2021 "Public Health Officer's Recommendations for Safe Board and Commission Meetings During COVID-19 Pandemic."

A motion was made by Melinda Peak, seconded by Nichole Jordan, to approve these findings. The motion was approved unanimously.

2) Landscape maintenance at County-managed cemeteries
