**BUSINESS PLAN EXEMPTION STATEMENT**

My business is exempt from the hazardous materials business plan requirements, as specified in the California Health & Safety Code, Chapter 6.95, Section 25503.5 (b) and/or (c), for the following reasons:

It does not handle a hazardous material, waste, or a mixture containing a hazardous material, in total quantities equal to or greater than:

1. 500 pounds of solids
2. 55 gallons of liquids
3. 200 cubic feet of compressed gasses at standard temperature and pressure
4. Quantities of radioactive materials for which an emergency plan is required pursuant to Parts 30, 40 or 70 of Chapter 10, Title 10, Code of Federal Regulations (CFR), or equal to or greater than the amounts specified above, whichever amount is less. Cumulative quantity is defined as the total amount of hazardous materials categorized into one Department of Transportation Hazard Class as described in 49 CFR.

***\* Note – Businesses generating any quantity of hazardous waste are still required to file a hazardous waste contingency plan.***

The hazardous materials handled by this business are contained solely in a consumer product which is packaged for direct distribution to, and use by, the general public (i.e. retail).

Oxygen, nitrogen, and nitrous oxide, ordinarily maintained by a physician, dentist, podiatrist, veterinarian, or pharmacist, at his or her office or place of business, stored at each office or place of business in quantities of not more than 1,000 cubic feet of each material at any one time is exempt from the business plan requirements.

Lubricating oil is exempt from the business plan requirements for a single business facility if the total volume of each type of lubricating oil handled at that facility does not exceed 275 gallons at any one time.

This business is a farm and an annual hazardous material inventory is submitted to the County Agricultural Commissioner. All buildings, which contain petroleum products, pesticides or fertilizers have been posted as such.

The storage site is an unmanned remote facility located in an isolated sparsely populated area and the types and quantities of materials onsite are limited to one or more of the following:

1. 500cubic feet of inert gasses
2. 1,200 gallons of flammable gasses
3. 500 gallons of flammable and combustible liquids
4. 200 gallons of corrosive electrolyte liquid

**And**

1. The facility is secured and not accessible to the public.
2. Warning signs are posted pursuant to the California Fire Code.
3. A one time notification, inventory and filing fee have been submitted to the Department
