- 1. Call To Order by Chairman Nelson at 7:05pm
 - 1) Roll call Weddle, Denega, Byrne, Babbitt, Nelson, Mikkola
 - 2) Shelly Blair DFW Environmental Scientist
- 2. Adoption of Minutes of 1/27/16 and Agenda for 2/24/16 were approved unanimously
- 3. Public Comment Public comment on non-agenda items None
- 4. Biologists and Warden Reports -
 - 1) Shelly Blair shared contact information for Jane VanCamp who has volunteered to help at the Lumsden Kids Fishing Derby
 - 2) Shelley will meet with the Mosquito Volunteer Fire Dept (MVFD) spokesman to go over a proposed land swap between property owner and the MVFD
 - 3) Shelley summarized negative conditions beginning to surface in the El Dorado Ranch including, dumping, illegal trespassing, environmental damage, and more
