NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE is hereby given that El Dorado County, within the State of California intends to adopt a Mitigated Negative Declaration for the project described below.

TITLE: SOUTH TAHOE GREENWAY – UPPER TRUCKEE RIVER BRIDGE AT JOHNSON MEADOW PROJECT

LOCATION: The Project area is located in eastern El Dorado County, within the Lake Tahoe Basin, in the City of South Lake Tahoe. The Project is bounded by Winnemucca Avenue and South Avenue from the west, Lake Tahoe Airport to the south, crosses the Upper Truckee River, Sierra Boulevard to the east.

Assessor Parcel Number (APN): County road rights-of-way and APNs 031-020-052, 031-020-042, 031-020-033, 031-020-045, 025-061-024, 025-472-011, 025-472-010, 025-472-009, 025-472-008, 025-472-007, 025-472-006, 025-472-005, 025-472-004, 025-472-003, 025-472-002, 025-472-012, 025-462-018, and UN0-164-020.

GENERAL DESCRIPTION: El Dorado County, Department of Transportation (County), is proposing to: construct a Class 1 shared-use path, install erosion control and water quality improvements to reduce the discharge of sediment and pollutants to the Upper Truckee River from County administered rights-of-way and publicly owned properties. The proposed improvements include, but are not limited to: pathway and drainage improvements including signage, boardwalk, and bridge crossing over the Upper Truckee River.

REVIEW: The review period for the Mitigated Negative Declaration begins on <u>August 30, 2024</u>, and ends on <u>September 30, 2024</u>. The Mitigated Negative Declaration may be reviewed at the El Dorado County, Department of Transportation offices at 924 B Emerald Bay Road, South Lake Tahoe, California.
