NOTICE OF INTENT TO ADOPT
A MITIGATED NEGATIVE DECLARATION

NOTICE is hereby given that the County of El Dorado, State of California intends to adopt a Mitigated Negative Declaration for the project described below.

TITLE: Country Club Heights Erosion Control Project

LOCATION: The Project area is located in eastern El Dorado County, within the Lake Tahoe Basin, south of South Lake Tahoe. The Project is bounded by Highway 50 to the west, Southern Pines Drive, Crystal Air Drive, and Skyline Drive to the south, Crystal Air Drive and Elks Club Drive to the east, and the subdivision boundaries to the north.

APN: County road right-of-way and APNs 033-100-23, 033-221-03, 033-222-17, 033-223-05, 033-201-32, 033-201-04, 033-211-09, 033-212-03, 033-212-09, 033-213-05, 033-301-01, 033-291-07, and 034-753-02.

GENERAL DESCRIPTION: El Dorado County Community Development Agency, Transportation Division, is proposing to: install erosion control and water quality improvements to reduce the discharge of sediment and pollutants to Lake Tahoe from County administered rights-of-way. The improvements will be to the existing storm water conveyance system which is comprised of channels, basins, culverts, inlets, and infiltration system.

REVIEW: The review period for the Mitigated Negative Declaration begins on February 6, 2017 and ends on March 7, 2017. The Mitigated Negative Declaration may be reviewed at County Transportation offices at 924B Emerald Bay Road, South Lake Tahoe, CA.
