## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE is hereby given that El Dorado County, within the State of California intends to adopt a Mitigated Negative Declaration for the project described below.

## TITLE: SAN BERNARDINO CLASS 1 BIKE TRAIL PROJECT

**LOCATION:** The Project area is located in eastern El Dorado County, within the Lake Tahoe Basin, in the unincorporated community of Meyers. The Project is bounded by U.S. Highway 50 to the south, North Upper Truckee Road to the west, crosses the Upper Truckee River, Apache Avenue to the east, and a bridge crossing over the Upper Truckee River.

Assessor Parcel Number (APN): County road right-of-way and APNs 034-020-012, 034-020-017, and 034-010-013.

**GENERAL DESCRIPTION:** El Dorado County, Department of Transportation (County), is proposing to: construct a Class 1 shared use pathway, install erosion control and water quality improvements to reduce the discharge of sediment and pollutants to the Upper Truckee River from County administered rights-of-way and publicly owned properties. The proposed improvements include, but are not limited to: pathway and drainage improvements including Class 3 bike route signage, boardwalk, and bridge crossing over the Upper Truckee River.

**REVIEW:** The review period for the Mitigated Negative Declaration begins on March 20, 2020 and ends on April 20, 2020. The Mitigated Negative Declaration may be reviewed at the El Dorado County, Department of Transportation offices at 924 B Emerald Bay Road, South Lake Tahoe, California.
