Pursuant to the administrative relief criteria and procedures adopted by the Board of Supervisors on April 17, 2007, the applicant does not qualify for Development Services Director approval, and Agricultural Commission review shall be required, as described in Section A, Subsection 4. (District 2)

<u>Staff Recommendation</u>: Staff recommends DENIAL of Dwayne Fisher's request for administrative relief of agricultural setbacks as staff cannot make the findings that the Commission are required to make by Resolution No. 079-2007 and adopted by the Board of Supervisors on April 17, 2007.

If the requested reduction cannot meet the administrative criteria, an application may be made to the Board of Supervisors for administrative relief, such relief may be granted by the Board of Supervisors upon a determination by the Board taking all relevant facts into consideration that he public interest is served by the granting of the relief. Such applications shall be made to the Development Services Department and a recommendation made to the Board of Supervisors.

VII. BLA 10-0015 – Boundary Line Adjustment on Williamson Act Contract # 202 (John White): requesting a lot line adjustment to move an interior boundary of APN 093-090-03, part of Williamson Act Contract #202, located on the north side of Happy Valley Road in the Somerset area. (District 2)

<u>Staff Recommendation</u>: Staff recommends APPROVAL of BLA 10-0015, as the findings for Government Code Section 51257 (a) can be made if the original contract is rescinded and a new contract is simultaneously entered into, the parcel continues to meet the minimum requirements for the Williamson Act Contract and the findings for General Plan Policy 8.1.4.1 can be made: the proposed use

- A. Will not intensify existing conflicts or add new conflicts between adjacent residential areas and agricultural activities; and
- B. Will not create an island effect wherein agricultural lands located between the project site and other non-agricultural lands will be negatively affected; and
- *C.* Will not significantly reduce or destroy the buffering effect of existing large parcel sizes adjacent to agricultural lands.
