#### 4. BIAC SUB COMMITTEE: Follow up on TRAKIT processes

Discussion on TRAKiT topics resumed. Topics of importance and priority are to 1) maintain good customer service and 2) the ability to result inspections in a timely manner, 3) fee calculations in processing permits, 4) the GIS system being carried over to TRAKiT correctly and 5) LMIS information transferred in duplication. It was noted that other jurisdictions are having issues as well.

Michael Elliott informed the committee that TRAKiT is offering the newest version #18 to the county.

Tiffany Schmid stated that she believes GIS information has been successfully transferred into TRAKiT.

Lori Burne stated that is too early to address the Board of Supervisors with TRAKiT issues. We need more time to work on TRAKiT's internal issues.

The committee agreed, and will continue to address TRAKiT issues internally.

SB 330 Allow change in zoning from high density to low density

SB 550 Density Bonus for building locations near mass transportations or job heavy areas

AB 1386 Closing Fees are due at the end of escrow

AB 1843 Posting of all information must be on website (Planning Policy)

AB 1484 All Fees must be posted on website
