4. EL DORADO COUNTY MS4 REQUIREMENTS FOR CONSTRUCTION MANAGEMENT PRESENTATION BY BRENDAN FERRY and AMY PHILLIPS CONTINUED FROM OCTOBER 15, 2014 (HANDOUTS FROM MEETING ATTACHED)

Brendan Ferry introduced an abbreviated slide show. Brendan Ferry asked for guidance, direction and assistance moving some of these policies forward to the Board. Brendan Ferry referenced Ordinance #4992, Chapter 8.79 of Title 8—Revise Lake Tahoe specific text in the Storm Water Quality Ordinance to El Dorado County as a whole. Brendan Ferry explained that we have a clear permit requirement of this ordinance to broaden our scope, our legal authority to the West Slope. Earl McGuire questioned if the permit is compatible with South lake Tahoe. Brendan Ferry stated that the permit is compatible. Brendan Ferry and Amy Phillips meet constantly with South Lake Tahoe as well as with the City of Placerville, quarterly. Brendan Ferry acknowledged that new knowledge, skills, understanding, designers, builders and developers are needed to make this State wide program work cohesively. This ordinance is in line with the rest of the state.

Bill Fisher stated that a balance is needed in the ordinance. The ordinance should leave some discretion for interpretation. Brendan Ferry is receptive to recommendations on this ordinance and would like to hear input.

Brendan Ferry and Amy Phillips plan to present in early March with draft final, allowing plenty of time to finalize prior to the June 30th hearing date.

Item 4 (Continued) Discussions: The intent of the ordinance, Brendan Ferry stated is to go after the major offender no the average person. Jerry Homme questioned how the Ordinance would be interpreted once a contractor received his permit. Brendan Ferry Explained that under an open permitted project with the county, the requirements are clearly stated on the checklist and permit approval. One should know before one signs on the dotted line what the rules are.

Suggestions, standard plans, storm water management plans are in place to help the public Know what tools to use. Jeff Haberman suggested a handout with rules, and problem solving ideas. Jerry Homme suggested a concise general statement be presented so that the public knows exactly what is being asked of them. Earl McGuire brought up the issue of what is applicable to the specific projects, and the length of the paperwork involved.

Brendan Ferry stated that he has met with Development Services to coordinate what this Permit is saying from a resource standpoint.

Brendan Ferry stated the following tentative dates/deadlines:

February 24, 2015: Program overview with supervisors to discuss trash amendments and Storm Water ordinances

May 5, 2015: Adoption of ordinance

Brendan Ferry and Amy Phillips created a brochure to provide simple rules, explanations and links to further information.
